GENERAL

The AAL Basic Digital Flight Instrument, Kit allows for the replacement of the OEM manufacturer's attitude and heading instruments with standalone digital instruments.

SECTION 1 **OPERATING LIMITATIONS****Types of Operation**

1. Limited to day and night VFR use.
2. The following Kelly Manufacturing Company Installation/Operating Guides or later applicable revisions, must be immediately available to the flight crew when operating the Attitude Indicator and the Heading Indicator, as applicable.

3. Both Attitude Indicators must have the same software version installed.
4. Both Heading Indicators must have the same software version installed.

SECTION 2 **NORMAL PROCEDURES**

1. No change to the approved Basic Flight Manual.

CAUTION

**Do not press and hold both “DIM” buttons on the heading indicator simultaneously for 10 seconds. Depending on software version, this may put the heading indicator into Magnetic Calibration Mode.

SECTION 3 **EMERGENCY PROCEDURES**

1. In a complete power loss situation, the Attitude Indicators will display a “POWER LOSS” indication and automatically switch to battery mode. The onboard back-up batteries will provide approximately 1 hour of service.

SECTION 4 **MALFUNCTION PROCEDURES**

1. If any of the instruments displays a prominent red "X" across the screen for any reason and it does not re-set itself within 3 minutes then consider the instrument unserviceable.
2. In a low voltage situation, the instruments will display an orange "LOW VOLTAGE" warning notice near the bottom of the display. This warning will appear when voltage drops below 11 volts. Below 5 volts the attitude indicators will automatically switch to battery power. Below 7.5 volts the heading indicators will display a red "X" indicating that the instruments are not reliable. Below 5 volts they will shut down.
